

**MINUTES
CITY COUNCIL SPECIALLY CALLED MEETING
MAY 15, 2017
3:00 P.M.**

CALL TO ORDER: Mayor Pro-Tem Jason Power called the meeting to order at 3:00 p.m.

ROLL CALL: Present were Mayor Pro-Tem Jason Power, Councilmember Angie Smith, Councilmember Caleb Phillips, Councilmember Mike Sosebee, City Attorney Dana Miles, City Manager Bob Bolz, and City Clerk Bonnie Warne.



Mayor Pro-Tem/Councilmember Jason Power


